Thence S. $75^{\circ}-36'-45''$ W. 2786.9' to the north line of Sec. 8, T. 48N., R. 14W., the place of beginning and north boundary of described parcel.

Thence continuing S. $75^{\circ}-36'-45''$ W. 5413' to the E- $S\frac{1}{4}$ line of Section 7, T. 48N., R. 14W., the west boundary of described parcel,

Right-of-Way shall be 150' wide on the northwesterly side of described reference line for the entire distance.
